ARTIST ANTHONY GILMORE WORKED WITH THE DEPARTMENT OF ENVIRONMENTAL QUALITY AND PUBLIC WORKS TO CREATE AN INTERACTIVE GAME AND WORKSHOP BASED ON THE STORIES OF CITY WORKERS IN THE DEPARTMENT. IT IS BEING USED BY CLASSROOMS ACROSS THE CITY TO HELP YOUNG PEOPLE UNDERSTAND THE CHALLENGES OF WORKING IN LOCAL GOVERNMENT.
